Oracle Intelligence Business Foundation Licenses and Maintenance

On February 27, 2014, as a result of a competitive General Services Administration (GSA) Federal Supply Schedule task order procurement (contract no. GS35F0265X, order no. NRC-HQ-7N-14-T-0001) was awarded on a firm-fixed-price basis to immixTechnology, Inc., of McLean, VA. This order will provide Oracle Intelligence Business Foundation Licenses and Maintenance. The period of performance is from February 28, 2014 to February 27, 2015, with two 1-year options. The total value for the task order is \$572,532.11, inclusive of all options.

Cyber Security Program Support Services

On February 28, 2014, as a result of a competitive GSA Alliant Small Business Governmentwide Acquisition Contract program task order procurement (GS06F0641Z), 16 task orders (one per office that is participating in the acquisition) were awarded to MAR, Incorporated of Rockville, MD. The task orders utilize the firm-fixed-price and labor-hour contract type. The orders will provide support for the U.S. Nuclear Regulatory Commission (NRC) in complying with cyber security regulations and maintaining a robust cyber security system. The periods of performance are from February 2014 to February 2015, with six 1-year options and one 3-month option. The total amount for the 16 task orders is \$57,208,611.47, inclusive of all options.

On March 5, 2014, NRC published a document in the *Federal Register* (79 FR 12362) confirming the effective date of March 11, 2014, for the direct final rule that was published in the *Federal Register* on December 6, 2013 (78 FR 73379), and corrected on December 26, 2013 (78 FR 78165). This direct final rule amended the NRC's spent fuel storage regulations by revising the Holtec International HI-STORM 100 Cask System listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 9 to Certificate of Compliance No. 1014.
