Translation and Interpretation Services

On June 12, 2014, as a result of an 8(a) non-competitive solicitation, an Indefinite Delivery, Indefinite Quantity, with Fixed Price and Labor Hours Line Items contract (NRC-HQ-7P-14-E-0001) was awarded to Language on Demand, Inc., in Fairfax, VA for translation and interpretation services. The period of performance is June 13, 2014, through June 12, 2015, with four 1-year option periods. The total estimated ceiling cost is \$948,440, inclusive of all options.

Records Storage and Archives

On June 12, 2014, under legislative authority of 31 USC §1535 of The Economy Act, and 44 USC §2901 note, (Public Law 106-58), a fixed-price interagency agreement (NRC-HQ-10-14-I-0009) was awarded to the National Archives & Records Administration (NARA) of College Park, MD. This agreement provides records center storage and services. The period of performance is October 01, 2013, through September 30, 2014. The total price is \$175,000.00.

List of Approved Spent Fuel Storage Casks: Transnuclear, Inc. Standardized Advanced NUHOMS® Horizontal Modular Storage System; Amendment No. 3: Direct Final Rule; Withdrawal; 10 CFR Part 72 (RIN 3150-AJ31; NRC-2013-0271)

On June 25, 2014, the NRC published a document in the *Federal Register* ([79 FR 35911](#)) withdrawing a direct final rule that would have revised its spent fuel storage regulations to include Amendment No. 3 to Certificate of Compliance No. 1029, Transnuclear, Inc. Standardized Advanced NUHOMS® Horizontal Modular Storage System listing within the “List of approved spent fuel storage casks.” The NRC is taking this action because it has received at least one significant adverse comment in response to a companion proposed rule that was concurrently published with the direct final rule.
