Dear Mr. Erlanger,

On December 20, 2013, Secured Transportation Services (STS) (NRC Docket 070-07011) requested renewal of the NRC Rail route from Joint Bases Charleston- Weapons Station (JBC-WS) (formerly Naval Weapons Station- Charleston), Goose Creek, SC to the Savannah River Site (SRS), Aiken, SC. The purpose of this letter is to correct the 10CFR reference and planned shipment timeframe. The changes are underlined.

Per 10CFR73.37(b)(1)(vi), STS hereby requests renewal of the rail route from JBC-WS to SRS. The details of the route are contained in a separate attachment, marked as "Safeguards Information".

The next shipment is tentatively scheduled for fall 2014 and STS request renewal prior to the route expiration date, if possible.
