On August 15, 2014, the U. S. Nuclear Regulatory Commission (NRC) completed a security inspection at the Calvert Cliffs Nuclear Power Plant. The NRC inspectors discussed the results of the inspection with you and other members of your staff. The inspectors documented the results of this inspection in the enclosed inspection report.

The inspectors did not identify any findings or violations of more than minor significance.
