Dear Ms. Aponte:

On behalf of the U.S. Nuclear Regulatory Commission (NRC), I am responding to your letter received on August 20, 2014. In your letter, you appealed the agency's August 12, 2014, decision to deny your August 8, 2014, Freedom of Information Act/Privacy Act (FOIA/PA) request (FOIA/PA-2014-0378). You had requested documents that you believe were "previously released and detailed...in FOIA #2014-0134."

The NRC did not release the documents requested in FOIA-2014-0134. In that underlying case (filed by a different requester than you), the NRC withheld all records in full and cited FOIA Exemption 5. In your appeal, you have argued that the NRC must provide a more complete justification for application of Exemption 5.

FOIA Exemption 5 concerns certain classes of communication, which are protected by legal privileges, and which occur inside an agency or between agencies. In FOIA-2014-0134, the NRC withheld all records in full from the original requester; that requester has not filed an administrative appeal.

Your FOIA request (FOIA/PA-2014-0378), sought documents you said the NRC released under a prior FOIA request. In the closure of your request (enclosed as Document 1), the agency informed you that "[t]here were no responsive records released in whole or in part in response to FOIA-2014-0134," and that "No agency records subject to the request have been located." In this instance, the NRC made the correct decision at the administrative level. Since the NRC did not release any records in that prior FOIA request, a "no document" response was appropriate. The NRC has not invoked any FOIA exemption in the processing of your request.

Acting on your appeal (enclosed as Document 2), I have carefully reviewed the record in the case. I have determined that the NRC properly denied your request because the agency did not release the records that you claim were released.

This is the NRC's final decision as to your appeal of the use of Exemption 5. As set forth in the FOIA (5 U.S.C. 552(a)(4)(B)), you can obtain judicial review of this decision in a district court of the United States in the district in which you reside or have your principal place of business. You can also obtain judicial review in the district in which the agency's records are situated or in the District of Columbia.

Re: Freedom of Information Act Appeal

Dear Ms. Argent:

I am writing to respectfully submit an appeal under the Freedom of Information Act.

On August, 8, 2014, I requested documents under the Freedom of Information Act. My request was assigned the following identification number: FOIA/PA-2014-00378, under the responsibility of Mark Graff. On August 15, 2014, I received a response to my request and would like to appeal its denial.

The letter I received stated that NRC was denying my FOIA request based on Exemption 5, which exempts inter-agencyor intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency.

However, the documents that were withheld must be disclosed either entirely or in part under the FOIA for two reasons:

- 1. The withheld documents "must fall within the ambit of a privilege against discovery under judicial standards that would govern litigation against the agency that holds it." (Dep't of Interior v. Klamath Water Users Protective Assn., 532 U.S. 1 (2001)). However, the documents withheld from this FOIA request are not subject to denial based on the rule of discovery privilege. NRC has not provided an explanation claiming that the withheld documents are protected from discovery for any active litigation or pre-litigation judicial proceedings. If this is not the case, and NRC is in fact involved in any active litigation or pre-litigation in which the withheld documents are likely to be subject to discovery privilege, I request that NRC please release the Title, Case Number, and Court in which the judicial proceedings are being heard. Otherwise, please released the withheld records as required.
- 2. The FOIA Exemption 5 does not cover purely factual portions of any pre-decisional documents. If any internal NRC memorandum contains advisory recommendations (and the NRC has yet to make a final decision on those recommendations), the documents should be released with only the portions related to active decision-making processes redacted. If a decision on the advisory recommendations of Dr. Michael Peck has already been made, the entire "post-decision" document is not subject to exemption under FOIA. Please confirm whether a decision is still pending or not, and release the records entirely or in part as required.
