DOMINION VIRGINIA POWER TO DISCUSS A FUTURE NORTH ANNA LICENSE AMENDMENT REQUEST TO SUPPORT THE HIGH BURNUP FUEL IN DRY STORAGE DEMONSTRATION PROJECT (TAC NO.

L24886)

PURPOSE

For Dominion Virginia Power to provide a status update on the high burn-up dry cask demonstration project proposed for the North Anna Power Station.

MEETING SUMMARY

The second pre-application meeting took place on October 7, 2014, from 1:00 p.m. to 3:00 p.m., at the U.S. Nuclear Regulatory Commission (NRC) Three White Flint North Building in Rockville, Maryland. Attendees included staff from Dominion Virginia Power (Dominion), NRC's Division of Spent Fuel Management (SFM), Areva - Transnuclear, Inc. (AREVA-TN), U.S. Department of Energy (DOE), Electric Power Research Institute (EPRI), Nuclear Energy Institute (NEI), electric utilities, and several members of the public. The attendance list is provided in Enclosure 1. The agenda is provided in Enclosure 2. The presentation slides are provided in Enclosure 3 (ADAMS Accession Number ML14276A654).

Dominion's staff discussed its proposed program for the storage of high burnup fuel and gas sampling data using a TN-32 cask, which will support its North Anna Independent Spent Fuel Storage Installation (ISFSI) amendment request. Dominion described technical aspects related to the implementation of the program including its licensing and regulatory perspectives, and schedule for the amendment. Dominion also provided an update on its proposed fuel selection, preliminary loading plan, baseline fuel data, data to be monitored, and upcoming site work.

For licensing considerations, Dominion will collaborate with AREVA-TN to develop the design and licensing basis document which will be submitted with the amendment request and will provide the analytical bases and conclusions for departures that were previously approved in the general license TN-32 Final Safety Analysis Report (FSAR). The amendment application is expected in July 2015 and Dominion plans to request an aggressive review schedule. Dominion also stated that an exemption from confinement regulation may be required and that they plan to have additional pre-application meetings with the NRC before submitting the amendment request.

The NRC staff raised questions and provided additional comments for Dominion to take into consideration, both in collecting data and preparing the amendment request.

Several members of the public raised a few questions and comments. One member questioned that given that North Anna is on a fault line, how did this site receive approval to perform this project without the consent of Virginians. Staff responded that North Anna has not yet received approval but is able to submit an amendment to their site-specific license which the NRC would review to ensure there is adequate protection of public health and safety and the environment. No regulatory decisions were made at the meeting.
