MEMORANDUM

(Date for Responses to Order to Show Cause)

By issuance dated October 22, 2014, the Licensing Board directed intervenor Oglala Sioux Tribe (OST) to show cause why its remaining admitted contention, OST Contention 2, entitled "Failure to Include Adequate Hydrogeological Information to Demonstrate Ability to Contain Fluid Migration," should not be dismissed and this proceeding terminated for want of prosecution. See Licensing Board Memorandum and Order (Order to Show Cause) (Oct. 22, 2014) at 1, 3 (unpublished). In that order, the Board also indicated that OST, as well as applicant Crow Butte Resources, Inc., (CBR) and the NRC staff, would have thirty days from the date upon which the Board's show cause order was published in the Federal Register to respond to the order. See id.

The Board's show cause order was published in the Federal Register on October 28, 2014. See Crow Butte Resources, Inc. (Marsland Expansion Area); Memorandum and Order (Order to Show Cause), 79 Fed. Reg. 64,233 (Oct. 28, 2014). Consequently, in accord with

10 C.F.R. § 2.306(a), any responses to the Board's order by OST, CBR, and/or the staff must be submitted on or before Friday, November 28, 2014.
