
Dear Mr. Parker:

As you are aware, Oakwood Healthcare Inc. (Oakwood) entered into an affiliation agreement with Zieger Health Care Corporation also known as Botsford Health Care (Botsford) and Beaumont Health System. Under the terms of the affiliation agreement, the three organizations created a new, not-for-profit Michigan health system named Beaumont Health (BH). The closing of this transaction occurred on September 1, 2014.


As a result of the transaction, BH will directly become the sole member (or owner) of Oakwood Healthcare Inc. There will be no name change to any of Oakwood Healthcare Inc. NRC License Numbers, which will remain in the name of Oakwood Healthcare Inc.

Because BH will become the sole member (or owner) of Botsford and Beaumont Health System you have asked that both Botsford and Beaumont Health System sign the change of control agreement indicating their agreement that BH will comply with Oakwood Healthcare Inc.'s NRC License conditions stipulated in 21-04515-01, 21-11457-02, 21-17789-01, 21-16656-01, 21-32643-01, 21-32196-01 and 21-32468-01 which is indicated by their signatures below.
