The purpose of this letter is to notify the Nuclear Regulatory Commission (NRC) in accordance with 10 CFR 52.99(c)(1) of the completion of Virgil C. Summer Nuclear Station (VCSNS) Unit 3 Inspections, Tests, Analyses, and Acceptance Criteria (ITAAC) Item 3.1.00.01 for verifying that the Technical Support Center (TSC) has at least 1875 ft² of floor space. The closure process for this ITAAC is based on the guidance described in NEI 08-01 (Reference 1), which was endorsed by the NRC in Regulatory Guide 1.215.

ITAAC Statement

Design Commitment:

1. The TSC has floor space of at least 75 ft^2 per person for a minimum of 25 persons.

Inspections, Tests, Analyses:

An inspection will be performed of the TSC floor space.

Acceptance Criteria:

The TSC has at least 1875 ft^2 of floor space.

ITAAC Determination Basis

An inspection and dimensional check has been performed to demonstrate that a TSC has been established and meets the requirements of NUREG-0696 (Reference 2). This ITAAC performs inspections of the TSC to verify that it has at least 1875 ft² of floor space.

NUREG-0696, Section 2.4 requires the TSC to have a minimum working space provided of approximately 75 ft² per person for the personnel assigned to the TSC at maximum level of occupancy. NUREG-0696 also requires the TSC be sized for a minimum of 25 persons, including 20 persons designated by the licensee and 5 NRC personnel.

A licensed professional surveyor performed an inspection and dimensional check of the floor space of the TSC utilizing standard survey techniques in accordance with job specific field instructions. Two independent instruments were utilized to determine the dimensions of the TSC and any obstructions that reduced the floor space were measured and subtracted from the overall floor space area.

The results are documented in a certified survey data report (Reference 3). The floor space of the TSC was determined to be 6324 ft^2 which meets the acceptance criteria of at least 1875 ft^2 .

ITAAC Finding Review

In accordance with plant procedures for ITAAC completion, SCE&G performed a review of all findings pertaining to the subject ITAAC and associated corrective actions. This review found that there are no relevant ITAAC findings associated with this ITAAC. The ITAAC completion review is documented in the ITAAC Completion Package for ITAAC 3.1.00.01 (Reference 4) and available for NRC inspection.

ITAAC Completion Statement

Based on the above information, SCE&G hereby notifies the NRC that ITAAC 3.1.00.01 was performed for VCSNS Unit 3 and that the prescribed acceptance criteria are met.
