Subject: Result of Proprietary Review

Discussion: I discussed with Mr. Desgagne that there were certain items in the redacted version of their submitted procedures that did not appear to be proprietary. We would need additional information to why names of individuals and internal procedures (including references) and procedure numbers on the headers were redacted or submit redacted procedures that did not include those items. Mr. Desgagne stated that he would probably submit redacted procedures that did not include those items. I also discussed to line out the "This document contains information proprietary to MDS Nordion." on the redacted version instead of blackening it out. I stated that we would replace the redacted version in ADAMS such that no copy would be retained by the NRC of the first redacted version.

Action Required: Mr. Desgagne would submit new redacted version of the requested procedures that would not redact the names of individuals and internal procedures (including references) and procedure numbers on the headers. This will delay the determination if the documents were Proprietary beyond the October 30 date as stated in the October 8<sup>th</sup> letter to the licensee.
