In a letter dated September 25th 2014 (Reference 1), the NRC submitted to GEH a request for additional information related to Chapters 1, 2, and 12 of the ABWR DCD, Revision 5.

The purpose of this letter is to advise the staff the schedule by which GEH can respond to the requests for additional information contained in Reference 1.
