### **U.S. Nuclear Regulatory Commission Public Meeting Summary**

October 2, 2014

Title: Kick-off Meeting on the Advance Notice of Proposed Rulemaking (ANPR) - Potential

Changes to NRC Radiation Protection Regulations

## Purpose of the Meeting(s):

This was the second of a series of public meetings/webinars planned by the NRC staff to discuss the ANPR for potential changes to NRC's radiation protection regulations. The purpose of the meeting was to provide stakeholders an opportunity to discuss issues and associated questions that were identified in the 10 CFR Part 20 ANPR, which was published on July 25, 2014 in the Federal Register (79 FR 43284). During this meeting, the following issues were discussed: Issue 1 - Update 10 CFR Part 20 to align with International Commission on Radiological Protection (ICRP) Publication 103 Methodology and Terminology and Issue 2 - Occupational Dose Limit for the Lens of the Eye.

### **General Details:**

The NRC staff conducted a public meeting/webinar beginning at 1:00 p.m. eastern standard time (EST) to discuss Issue 1 - Update 10 CFR Part 20 to align with ICRP Publication 103 Methodology and Terminology and Issue 2 - Occupational Dose Limit for the Lens of the Eye, and associated questions for each issue that were identified in the 10 CFR Part 20 ANPR. The public meeting was transcribed. The meeting was scheduled for 1:00 - 5:00 p.m. EST, but ran approximately 1 hour.

Mr. William (Butch) Burton facilitated the meeting, who is an NRC in-house facilitator. The meeting began with an introduction of NRC staff and a review of meeting logistics and ground rules. Dr. Donald Cool, Sr. Level Advisor Senior Advisor for Radiation Safety and International Liaison, presented an overview of Issue 1 - Update 10 CFR Part 20 to align with ICRP Publication 103 Methodology and Terminology and its associate questions in the ANPR. Ms. Cindy Flannery, Sr. Health Physicist, presented an overview of Issue Occupational Dose Limit for the Lens of the Eye, and its associated questions in the ANPR. Although the majority of the meeting was designed to answer questions, the "question and answer" period was much shorter than anticipated.

There were 42 attendees at the meeting; 33 remotely on the webinar/webcast and 9 physically located in the room. The attendees included: Agreement States (13), one non - Agreement (Connecticut), the nuclear industry (15), academia (1), environmental organization (1), NRC staff (9), and members of the public (2). A complete list of the attendees and the organizations represented is attached.

### **Summary of Presentations:**

The NRC is considering amending its basic radiation protection regulations to achieve greater alignment between the NRC's regulations and the recommendations of the International Commission on Radiological Protection (ICRP) contained in ICRP Publication 103 (2007). On July 25, 2014, the NRC published in the Federal Register (79 FR 43284) ANPR to consider revisions to Title 10, "Energy," of the Code of Federal Regulations (10 CFR) Part 20, "Standards For Protection Against Radiation." The NRC issued the ANPR to obtain input from stakeholders on the development of a draft regulatory basis to support potential changes to 10 CFR Part 20. Issue - 1 - Update 10 CFR Part 20 to align with ICRP Publication 103 Methodology and Terminology, and

Issue – 2 - Occupational Dose Limit for the Lens of the Eye

### **Public Participation Themes:**

Issue 1: Questions were raised regarding NRC's analyses using the Department of Energy process for the age and gender assessment and U.S. population census data to determine whether there will be any substantial difference in the dose to the public, and how the public dose will be calculated and adjusted using U.S. Census for those members of the public living near the nuclear facilities.

Issue 2: Questions were raised regarding the establishment of eye protection factors and the certification of eye protection equipment?
