The following is a brief description of statements made during the above-referenced call:

- Chaisson: Yeah, I'll take those training courses; Laurie McGowan is gonna train me on the 40-hour course; she's the best in the industry, besides me
- Linda: discusses hearing rights; Chaisson: Oh, my money's back in my pocket, I'm making good money; I'm not going down, not his time, honey
- Linda: discusses how the Order will be sent (via email, then hard copy, and gets his home address; Chaisson: Oh send it, I'll be waiting on it
- Chaisson: Are we done, can I get back to work now? I'm making 48 dollars an hour out here reading film, but I aint makin nothing on this call; can I go now?
- Linda ends call.
