- SUBJECT: CLOSED MEETING WITH THE NUCLEAR REGULATORY COMMISSION AND EXELON GENERATION COMPANY, LLC REGARDING THE PHYSICAL SECURITY LICENSE AMENDMENT REQUEST FOR OYSTER CREEK NUCLEAR GENERATING STATION

On October 28, 2014, a closed meeting was held between the U.S. Nuclear Regulatory Commission (NRC) and representatives of the Exelon Generation Company, LLC (Exelon) at NRC Headquarters, Three White Flint North, 11601 Landsdown Street, North Bethesda, Maryland.

The purpose of the meeting was for NRC and Exelon to discuss the physical security license amendment request (LAR) for the Oyster Creek Nuclear Generating Station (Oyster Creek). This LAR contains Safeguards Information.

On October 20, 2014 (Agencywide Documents Access and Management System Accession No. ML14287A605), a meeting notice was issued. The meeting notice included a detailed meeting agenda.

The meeting began at 10:00 a.m. Eastern Daylight Time (EDT) with opening remarks by the NRC staff followed by introductions of the attendees. A list of attendees is provided in the Enclosure. The Exelon staff provided details of its proposed actions in its LAR to address physical security at Oyster Creek. The LAR contains safeguards information. The NRC staff and Exelon discussed safeguards information in a secure conference room.

At this meeting, the NRC staff made no regulatory decisions regarding the merits of the LAR regarding physical security at Oyster Creek.

The meeting was adjourned at 10:52 a.m. EDT.
