The U.S. Nuclear Regulatory Commission (NRC) completed its review of the information transmitted by your letter 14-113, dated October 27, 2014, which supplied replacement pages resulting from minor changes in Chapters 1 and 8 of the License Application regarding the name change from "BWX Technologies" to "Babcock & Wilcox Government and Nuclear Operations, Inc."

In a letter dated September 26, 2014, the staff had confirmed that the change was not a transfer of control, and an amendment was not required. The change was properly made in accordance with License Condition S-13.
