On October 14, 2014, GE Hitachi Global Laser Enrichment, LLC (GLE) submitted a revision to its Program Cyber Security Plan document GLEP-00015-R (Revision 2) (U.S. Nuclear Regulatory Commission's (NRC) Agencywide Documents Access and Management System (ADAMS) ML14308A126). The revision to this document represented minor changes to personnel roles designated within the Program Cyber Security Plan due to changes within the GLE Organization, along with changes to the descriptions of the network installation of the GLE Wilmington Campus laboratories as discussed during the recent NRC and U.S. Department Energy (DOE) inspection.

As the Authorizing Official (AO), the DOE Nuclear Energy Oak Ridge Site Office has reviewed the revised plan provided for GLE classified computer networks, and has provided GLE authorization to operate (ATO) the classified network in accordance with the "Program Cyber Security Plan - Engineering and Industrial Control System Environments for the GE Hitachi Global Laser Enrichment LLC Wilmington, NC Facilities (Program Cyber Security Plan)" GLEP-00015-R, Revision 2, dated October 13, 2014, for the processing of information up to, and including, Secret Restricted Data. The DOE provided the ATO in its letter to NRC dated November 3, 2014 (ML14307B095) (enclosed). This ATO will expire 3 years from the date of the DOE letter. To maintain this ATO, the continuous monitoring report must be submitted at least annually to the AO. Also, results of the security controls, which must be performed after receipt of this ATO, must be submitted with the next revision to the Program Cyber Security Plan to reflect the decommissioning of the remote laboratories.

A review of the subject document found that none of the changes are substantive and therefore, do not decrease the effectiveness of the current plan. Based our review of the revised plans submitted to the NRC on October 14, 2014, the NRC concludes that the plan is acceptable and in compliance with sections of Title 10 of *the Code of Federal Regulations* Part 95.
