In regard to the Requests for Additional Information transmitted in your April 24, 2014 letter, Reference 1, GEH's responses were provided in Reference 2. In regard to RAI 19-5, Enclosure 3 of Reference 2 provided eight ABWR DCD security-related figures. During work by our contractors to update the ABWR Aircraft Impact Analysis Report to address RAI 19-5, inconsistencies in three figures were identified that required those figures to be revised. The figures that required revision are Figures 9A.4-2, 9A.4-5, and 9A.4-6.

Enclosure 1 of this supplemental response to RAI 19-5 describes the additional changes to Figures 9A.4-2, 9A.4-5, and 9A.4-6 not already depicted in Reference 2.

Enclosure 2 contains the three revised DCD figures associated with this supplemental response. No other aspect of Reference 1 is modified in any way.

The figures in Enclosure 2 are Security-Related Information marked with the designation "{{{Security-Related Information – Withhold Under 10 CFR 2.390}}}." GEH requests that the NRC withhold from public disclosure Enclosure 2 in its entirety in accordance with the provisions of 10 CFR 2.390. Since the figures in Enclosure 2 are Security-Related Information in their entirety, no public version of Enclosure 2 is provided.
