SUBJECT: REQUEST FOR ADDITIONAL INFORMATION

Dear Mr. Svajger:

This refers to your license renewal application request dated October 28, 2014, (Agencywide Documents Access and Management System (ADAMS) No. ML14303A080) for U.S. Nuclear Regulatory Commission (NRC) exempt-distribution license number 34-25957-03E.

We do not have sufficient information to complete the review of your application. The documents listed in License Condition 13 are mostly old and should be replaced by a new document comprising an up-to-date description of your program. This new document should contain all of the information required by the regulations in Title 10, Code of Federal Regulations, Part 32 (10 CFR 32), sections 32.14, 32.15, 32.18, and 32.19. Much of the information you provided in your renewal application is relevant for the purpose of meeting the requirements of the regulations in 10 CFR 32; however, in the interest of clarity and transparency, you should address each of these requirements by responding to the questions in Enclosure 1 to this letter, either as a statement within the new document itself, or by referring to previously-submitted information that you will attach to this document. Previously-submitted information may include information that you provided in your October 28, 2014, renewal application. If so, you may either restate the information or specify where in the application that information was provided.

Your renewal application includes two drawings which contain the following statement: "This document contains information proprietary to the Fluke Corporation...." Please note that in order to request that NRC withhold information contained in an application from public disclosure, the applicant must submit the information and application, including an affidavit, in accordance with 10 CFR 2.390. The applicant should submit all of the information described in Enclosure 2 to this letter. Alternatively, you may resubmit the drawings (if necessary) without the proprietary markings.

We will continue our review upon receipt of this information. If we do not receive your reply within 30 calendar days from the date of this letter, we will consider your application as having been abandoned by you. This action would be without prejudice to the resubmission of another application with the required information.
