SUBJECT: OYSTER CREEK NUCLEAR GENERATING STATION – REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE REGARDING REVISION OF THE CORE OPERATING LIMITS REPORT FOR CYCLE 25, REVISION 10

Dear Mr. Pacilio:

By letter dated October 14, 2014 (Agencywide Documents and Access Management System Accession No. ML14297A403), Exelon Generation Company, LLC (Exelon) submitted a revision of the core operating limits report (COLR) for Cycle 25, Revision 10 at Oyster Creek Nuclear Generating Station (OCNGS). This COLR for Cycle 25, Revision 10 incorporates the revised cycle-specific operating limits from the new core configuration implemented during the OCNGS refueling outage. This COLR was submitted in accordance with OCNGS Technical Specification Section 6.9.1.f.4.

By letter dated October 14, 2014, Exelon submitted an affidavit dated August 13, 2014, executed by Mr. Lukas Trosman of Global Nuclear Fuel – Americas LLC (GNF-A) requesting that the information contained in the following document be withheld from public disclosure, pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Part 2, Section 2.390:

GNF-A proprietary report, 001N8127-FBIR-P, "Fuel Bundle Information Report for Oyster Creek Reload 25, Cycle 25," Revision 0, Class II (GNF-A Proprietary Information), dated August 2014.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- Information that discloses a process, method, or apparatus, including supporting data and analysis, where prevention of its use by GNF-A's competitors without license from GNF-A constitutes a competitive economic advantage over other companies.
- Information which, if used by a competitor, would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.

The U.S. Nuclear Regulatory Commission (NRC) staff has reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the



In all review situations, if the NRC makes a determination adverse to the above, you will be notified in advance of any public disclosure.
