**Agencywide Documents Access & Management System (ADAMS) P8 and Related Applications Operations and Maintenance Support**

On March 4, 2015, as a result of a non-competitive solicitation, time and materials task order number NRC-HQ-10-15-T-0001 was issued under Contract No. NRC-HQ-11-C-33-0059 to CGI Federal of Fairfax, Virginia. The task order provides for maintenance and operation support for ADAMS Core and Related Systems. The period of performance is from March 4, 2015, through September 25, 2015, with two 1-year option periods. The total estimated cost ceiling is \$7,965,871, inclusive of options.

On March 6, 2015, the NRC published a final rule in the *Federal Register* (80 FR 12073) amending its spent fuel storage regulations by adding the Holtec International HI-STORM Underground Maximum Capacity Canister Storage System, Certificate of Compliance No. 1040, to the "List of approved spent fuel storage casks." This final rule is effective on April 6, 2015.
