Dear Mr. Edington:

This letter refers to the investigation conducted by the U.S. Nuclear Regulatory Commission's Office of Investigations at Palo Verde Nuclear Generating Station; Inspection Report 05000528/2014405, 05000529/2014405, and 05000530/2014405 enclosed. The purpose of the investigation was to determine if a willful security-related violation at the Palo Verde Station. The investigation was initiated on June 14, 2013, and completed on May 2, 2014. Based on the evidence developed during the investigation, the NRC substantiated that a willful security-related violation occurred. This investigation is closed. The enclosed inspection report documents the inspection results, which were discussed on February 19, 2015, with Ms. M. Lacal, Vice President, Operations Support, and other members of your staff.

Nuclear Regulatory Commission (NRC) inspectors documented one finding of very low security significance (Green) in this report. This finding involved a violation of NRC requirements and this violation was also determined to be Severity Level IV under the traditional enforcement process. The NRC is treating this violation as a non-cited violation (NCV) consistent with Section 2.3.2.a of the Enforcement Policy.

If you contest the NCV or its significance, you should provide a response within 30 days of the date of this letter, with the basis for your denial, to the U. S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001; with copies to Director, Office of Enforcement, U. S. Nuclear Regulatory Commission, Washington, DC 20555-0001; the Regional Administrator, Region IV; and the NRC Resident Inspectors at the Palo Verde Station.
