Transfer of Responsibility for Kewaunee Power Station from NRR to NMSS

On March 12, 2015, NRR issued an internal memorandum to the Office of Nuclear Material Safety and Safeguards (NMSS), transferring project management responsibility for the Kewaunee Power Station from NRR to NMSS. This transfer is effective March 13, 2015. This is the first decommissioning power reactor to be transferred from NRR to NMSS since 2003. The transfer is based on completing certain licensing action regulatory milestones, the last of which was the issuance of the Kewaunee Defueled Technical Specifications.
