#### NAC International MAGNASTOR<sup>®</sup> System, Certificate of Compliance No. 1031, Amendment No. 4: Direct Final Rule; Confirmation of Effective Date: 10 Code of Federal Regulations (CFR) Part 72 (Regulation Identifier Number 3150-AJ39; NRC-2014-0058)

On March 27, 2015, the NRC published a document in the *Federal Register* (<u>80 FR 16251</u>) confirming the effective date of April 14, 2015, for the direct final rule that was published in the *Federal Register* (<u>80 FR 4757</u>) on January 29, 2015. The direct final rule amended the NRC's spent fuel storage regulations by revising the NAC International MAGNASTOR<sup>®</sup> System listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 4 to Certificate of Compliance No. 1031.

# Applicability of Risk-Informed Categorization Regulation to Combined Licenses: Petition for Rulemaking (PRM); Notice of Docketing: 10 CFR Part 50 (Docket Nos. PRM-50-110; NRC-2015-0028)

On March 27, 2015, the NRC published a notice of docketing in the *Federal Register* (<u>80 FR 16308</u>) for a PRM filed on January 15, 2015, by Michael D. Tschiltz, on behalf of the Nuclear Energy Institute (the petitioner). The petitioner requests that the NRC clarify the applicability of an NRC regulation to combined licenses. The NRC regulation allows structures, systems, and components of nuclear power reactors to be re-categorized based upon risk-informed considerations. The NRC is not requesting public comment on this PRM at this time.

#### Crystal River Unit 3 Emergency Plan License Amendment

On March 31, 2015, the staff issued an amendment to Duke Energy Florida for the Crystal River Unit 3 Nuclear Generating Station (CR-3) emergency plan. This is based upon the permanently shut down and defueled status of CR-3 and conforming to the as-exempted emergency planning regulations in 10 CFR 50.47 and 10 CFR Part 50, Appendix E. The licensee will continue to maintain an onsite emergency plan addressing the classification of an emergency notification and coordination with designated offsite government officials following an event declaration. If needed, offsite authorities may implement protective actions using a comprehensive emergency management (all-hazard) approach to protect public health and safety. The CR-3 revised emergency plan will no longer be required to contain elements of formal offsite radiological emergency preparedness, including the 10-mile emergency planning zone.
