I. <u>SECY-15-0033 – Shaw AREVA MOX Services, LLC (Mixed Oxide Fuel Fabrication</u> Facility Possession and Use License) – Denial of Petition for Review of LBP-14-1

The Commission approved a Memorandum and Order responding to Nuclear Watch South, Blue Ridge Environmental Defense League, and Nuclear Information and Resource Service's petition for review of the Atomic Safety and Licensing Board's Initial Decision in LBP-14-1. The Memorandum and Order denies the petition for review. To ensure that protected information is not inadvertently disclosed, at this time the Memorandum and Order will be released only to the parties. The Memorandum and Order directs the parties to jointly submit proposed redactions to this decision or a statement that no redactions are needed within ten days.
