The Commission is being asked to act on a Memorandum and Order responding to Nuclear Watch South, Blue Ridge Environmental Defense League, and Nuclear Information and Resource Service's petition for review of the Atomic Safety and Licensing Board's Initial decision in Licensing Board Panel 14-1.

The Commission (with Commissioner Baran dissenting) has voted to approve a Memorandum and Order, which denies the petition for review. To ensure that protected information is not inadvertently disclosed, at this time the Memorandum and Order will be released only to the parties.
