The Commission has voted to approve a Memorandum and Order with Commissioner Svinicki dissenting in part, that denies the hearing request in part and refers the request in part to the Atomic Safety and Licensing Board Panel and in part to the Executive Director for Operations for disposition under 10 C.F.R. § 2.206.
