Good Afternoon Rob,

After reviewing General Cable's responses there were two things that the NRC would like clarification. You can respond to this email and I'll incorporate your response(s) to the General Cable docket file. Upon resolution of these questions you will received an acknowledgment letter from the NRC for being responsive to the NONs.

1. [Response to Notice of Nonconformance 99900227/2015-201-03](#): Could you send us a copy of Report F-C5120-1, August through December 1979, Project C5120? We would like to verify that the

range of the Beckman Instrument met the ranged specified by the report. (Per your letter the Beckman instrument range is **Range/Features 10KV AC/DC, 1 OmA AC/DC**)

2. **Response to Notice of Nonconformance 99900227/2015-201-02** : It was not clear from your response what type of documented communication you had with Duke were you specifically informed them that the cable qualification did not extend to the PVC jacket and where Duke acknowledge responsibility for accepting the cables and their use in the plant. Your response details Duke performed analysis and agreed on a statement of "recommended removal". In order to make it more clear an acceptable objective evidence could be email correspondence between General Cable and Duke, especially if it happened recently capturing that both parties are aware of the limitation of qualification.
