Fidelis Communications Software Subscription

On May 25, 2015, as a result of a competitive solicitation, fixed-price purchase order number NRC-HQ-7S-15-P-0005 was awarded to Three Wire Systems, LLC in Falls Church, Virginia. The purpose of this order is to acquire a 5-year subscription to Fidelis Communications Command Post Native Mode Software. The period of performance is from May 29, 2015, through May 28, 2016, with four 1-year options. The total estimated price is \$172,632 inclusive of options.

Information Technology Solutions - Integrated Program and Project Support

On May 28, 2015, as a result of a competitive solicitation, blanket purchase agreement (BPA) number NRC-HQ-10-15-A-0001 was awarded to MBL Technologies, Inc. in Arlington, Virginia. The period of performance is from May 28, 2015, through May 27, 2020. The total estimated price is \$106,000,000.

On May 28, 2015, as a result of a competitive solicitation, BPA number NRC-HQ-10-15-A-0002 was awarded to Northramp, LLC in Reston, Virginia. The objective of the ITS-IPPS is to provide the NRC with a broad range of information technology and information management technical and professional services on a labor-hour or fixed-price basis. The period of performance is from May 28, 2015, through May 27, 2020. The total estimated price is \$106,000,000.

Evaluation of Agencywide Documents Access and Management System Operational and Other Capabilities

On May 29, 2015, as a result of a non-competitive solicitation, order number NRC-HQ-30-15-O-0001 was issued against BPA Number NRC-DR-33-10-324 to AEGIS Net, Inc. in New Castle, Delaware. The purpose of this order is to determine if NRC's Agencywide Documents Access and Management System (ADAMS) meets its required operational capabilities and adequately provides for functionality in serving as the agency's repository for official agency records. The period of performance is from May 28, 2015, through November 27, 2015. The total estimated price is \$197,304.

The direct final rule amended the NRC's spent fuel storage regulations by revising the Holtec International, Inc., HI-STORM Flood/Wind System listing within the "List of approved spent fuel storage casks," to include Amendment No. 1, Revision 1, to Certificate of Compliance No. 1032.

International Atomic Energy Agency Technical Working Group on Nuclear Power Plant Instrumentation and Control Meeting in Vienna, Austria

During the week of May 25-29, 2015, staff traveled to Vienna, Austria, to represent the Nuclear Regulatory Commission at the 25th Meeting of the International Atomic Energy Agency (IAEA) Technical Working Group on Nuclear Power Plant Instrumentation and Control (TWG-NPPIC). The primary purpose of the TWG-NPPIC is to provide advice and support to the IAEA in program planning and implementation. The TWG-NPPIC is the oldest of the IAEA TWGs and meets once every other year. Forty-four participants from nineteen member nations and two international organizations attended this meeting. At the meeting, the planning process for the 2016–17 program was completed, and the U.S. delegation was able to negotiate four of our highest priority items onto the planning agenda for the next 2 years (diversity and defense-indepth, safety aspects of computer security, commercial dedication of digital systems, and digital regulatory guidance harmonization.
