**Motor Surveillance Tracking and Monitoring of Shipments**

On June 1, 2015, interagency agreement number NRC-HQ-50-15-I-0001 was awarded to the U.S. Air Force, Surface Deployment and Distribution Command, in Scott Air Force Base, Illinois. The purpose of this contract is to formally establish the terms and conditions between the Nuclear Regulatory Commission (NRC) and the Air Force as they relate to the Defense Transportation and Tracking System (DTTS). The DTTS Operations Center will provide the capability for motor surveillance tracking and monitoring of certain shipments made by NRC licensees. The period of performance is from May 20, 2015, through April 30, 2020. The total estimated ceiling price is \$163,275.

**Radionuclide Data for Site Level 3 Probabilistic Risk Assessment and Code Assessment**

On June 2, 2015, under the enterprise-wide agreement number NRC-HQ-60-14-D-0005, task order number NRC-HQ-60-15-T-0014 was awarded to Department of Energy Oak Ridge National Laboratory (ORNL) in Oak Ridge, Tennessee. The purpose of this contract is to provide data for the Site Level 3 PRA, investigate the performance of the ORIGAMI tool, and, as requested, provide technical support. The period of performance is from June 1, 2015, through May 31, 2016. The total estimated ceiling price is \$150,000.

**Technical Support for Project Entitled “Radiological Assessment System for Consequence Analysis” Computer Code and Emergency Response Assessment Tools for NRC Operations Center**

On June 4, 2015, as a result of a total small business set aside, hybrid firm-fixed-price/cost-reimbursement contract number NRC-HQ-60-15-C-0003 was awarded to Athey Consulting in Charlestown, West Virginia. The purpose of this contract is to provide technical assistance in support of the Radiological Assessment System for Consequence Analysis (RASCAL) computer code and emergency response assessment tools for the NRC Operations Center. The period of performance is from June 14, 2015, through June 13, 2020, inclusive of four 12-month options. The total estimated ceiling price is \$1,293,600, inclusive of options.

**Technical Assistance to Support the Nuclear Regulatory Commission’s Implementation of the Programmatic Agreement Regarding the Ross in Situ Uranium Recovery Project in Crook County, Wyoming**

On June 9, 2015, as a result of a total small business set aside, cost-reimbursement task order number NRC-HQ-50-15-T-0001 was awarded under the NRC’s enterprise-wide contract number NRC-HQ25-14-E-0001 to NUMARK Associates in Washington, DC. The purpose of this task order is to provide technical and administrative assistance from a qualified archaeologist and a Section 106 travel consultation expert to support the NRC in the implementation of the Ross Project Programmatic Agreement. The period of performance is from June 9, 2015, through June 8, 2020, inclusive of two 1-year options. The total estimated ceiling price is \$393,700, inclusive of options.

**Public Meetings on Proposed Medical Isotope Production Facility for SHINE Medical Technologies, Inc.**

On June 10, 2015, the staff held two identical public meetings at the Rotary Botanical Gardens in Janesville, Wisconsin, to discuss the preliminary findings of, and receive public comments on, the draft environmental impact statement (EIS) for the SHINE Medical Technologies, Inc. (SHINE) construction permit application for a medical isotope production facility. After weighing the environmental impacts and considering reasonable alternatives, the preliminary finding of this report is that the NRC staff recommends the issuance of the proposed construction permit to SHINE, unless safety issues mandate otherwise. Approximately 30 people attended each meeting. Public comments received focused primarily on accidents, alternatives, safety-related concerns, and opposition to the project. The public comment period closes on July 6, 2015. The staff plans to issue the final EIS in October 2015. In addition to the public meetings on the draft EIS, the staff held a government-to-government meeting that included approximately 30 local, State, and Federal officials. Officials asked many insightful questions regarding the safety, security, and environmental reviews related to the SHINE project.
