SUBJECT:	STAFF REQUIREMENTS – SECY-15-0048 – REQUEST FOR APPROVAL OF STAFF RECOMMENDATION TO AUTHORIZE BABCOCK AND WILCOX NUCLEAR OPERATIONS GROUP- LYNCHBURG TO USE SECTION 161A PREEMPTION AUTHORITY

The Commission has approved authorization for use of Atomic Energy Act Section 161A preemption authority by Babcock and Wilcox Nuclear Operations Group, Inc. (B&W NOG) at the B&W NOG-Lynchburg facility. The Commission has authorized the Director of the Office of Nuclear Material Safety and Safeguards to complete the required license amendment actions and issue the draft Final Confirmatory Orders included in SECY-15-0048, subject to the enclosed edit being made to the Order. The staff should coordinate with the Office of the Secretary to finalize and issue the letter to the Governor of Virginia concurrent with issuance of the final Confirmatory Orders and the associated *Federal Register* notice.
