Office of Administration (ADM) Items of Interest Week Ending June 19, 2015

Physical Protection of Category 1 and Category 2 Quantities of Radioactive Materials: Petition for Rulemaking; Consideration in the Rulemaking Process; Part 37 of Title 10 of the Code of Federal Regulations (NRC-2014-0172; NRC-2015-0094)

On June 12, 2015, the NRC published a document in the *Federal Register* (<u>80 FR 33450</u>) informing the public that it will be considering in its rulemaking process a Petition for Rulemaking (PRM), PRM-37-1, filed by Anthony Pietrangelo on behalf of the Nuclear Energy Institute (the petitioner). The petitioner requested that the NRC amend its regulations to clarify and expand current exemptions for when the physical protection measures for Category 1 and Category 2 quantities of radioactive material do not apply to a licensee.

Revisions to Transportation Safety Requirements and Harmonization with International Atomic Energy Agency Transportation Requirements; Final Rule; 10 CFR Part 71 (Regulation Identifier Number (RIN) 3150-AI11; NRC-2008-0198)

On June 12, 2015, the NRC published a final rule, in consultation with the U.S. Department of Transportation (DOT), in the *Federal Register* (<u>80 FR 33988</u>) amending its regulations for the packaging and transportation of radioactive material. These amendments make conforming changes to the NRC's regulations based on the International Atomic Energy Agency's 2009 standards for the international transportation of radioactive material and maintain consistency with the DOT's regulations. In addition, these amendments re-establish restrictions on materials that qualify for the fissile material exemption, clarify requirements, update administrative procedures, and make editorial changes. This rule is effective July 13, 2015.

Financial Qualifications for Reactor Licensing; Draft Regulatory Basis; Public Meeting and Request for Comment; 10 CFR Part 50 (RIN 3150-AJ43; NRC-2014-0161)

On June 17, 2015, the NRC published a draft regulatory basis in the *Federal Register* (80 FR 34559) for a proposed rulemaking to amend the current financial qualification requirements of "reasonable assurance" to the review standard of "appears to be financially qualified." The NRC plans to hold a public meeting on July 8, 2015, from 1:00 p.m. - 4:00 p.m. at the NRC Headquarters in Rockville, MD, to promote full understanding of this regulatory basis and to facilitate public comment. Comments are due by August 3, 2015.

Unified Agenda of Federal Regulatory and Deregulatory Actions; Semiannual Regulatory Agenda; 10 CFR Chapter I (NRC-2015-0071)

On June 18, 2015, the NRC published in the *Federal Register* (<u>80 FR 35170</u>) its Semiannual Regulatory Agenda (the Agenda) in accordance with Public Law 96-354, "The Regulatory Flexibility Act," and Executive Order 12866, "Regulatory Planning and Review." The Agenda is a compilation of all rules on which the NRC has recently completed action, has proposed, or is considering action. This issuance of the NRC's Agenda contains 35 active and 23 long-term rulemaking activities: two are "economically significant"; 10 represent "other significant agency priorities"; 53 are "Substantive, nonsignificant rulemaking activities;" and one is an "administrative rulemaking activity." In addition, three rulemaking activities impact small entities. Comments are due by July 20, 2015.
