Reactor Pressure Vessel Fluence Evaluation Methodology Guidance

On July 1, 2015, as a result of a non-competitive solicitation, cost-reimbursement task order NRC-HQ-60-15-T-0020 was issued under Interagency Agreement NRC-HQ-25-14-D-0004 to Oak Ridge National Laboratory, in Oak Ridge, Tennessee. The objective of this task order is to apply rigorous computational approaches to analyze the fluence at vessel locations above and below the reactor core, which includes reactor vessel internal components. The period of performance is from July 1, 2015, through November 30, 2018. The total estimated cost ceiling is \$1,502,000.

Issuance of Byron and Braidwood License Renewal Application Safety Evaluation Report On July 6, 2015, the staff issued the final Safety Evaluation Report (SER) related to the Byron Nuclear Station, Units 1 and 2, and Braidwood Nuclear Station, Units 1 and 2, license renewal application (LRA), which Exelon Generation Company, LLC, (Exelon) submitted to the NRC in May 2013. The final SER summarizes the results of the staff's safety review of the LRA in accordance with Title 10 of the Code of Federal Regulations, Part 54, "Requirements for Renewal of Operating Licenses for Nuclear Power Plants," and describes the technical details considered in evaluating the proposed operation of the plant for an additional 20 years beyond the term of the current operating license.
