Safety Culture and Climate Survey

On July 14, 2015, as a result of a non-competitive solicitation, fixed-price task order NRC-HQ-30-15-T-0001 was issued under General Services Administration Schedule GS10F0170P to Towers Watson Delaware, Incorporated in Arlington, VA. The objective of this task order is to assist the Office of the Inspector General in assessing the current organizational safety culture and climate of NRC's workforce. The period of performance is from August 1, 2015, through February 1, 2016. The total ceiling price is \$253,727.

<u>Power Reactor In-Core Monitoring: Petition for Rulemaking; Notice of Docketing; Part 50 of Title 10 of the Code of Federal Regulations (NRC-2015-0124)</u>

On July 16, 2015, the NRC published a notice of docketing in the *Federal Register* (80 FR 42067) for Petition for Rulemaking (PRM) 50-111 that was filed on March 13, 2015, by Mark Edward Leyse (the petitioner). The petitioner requests that the NRC amend its "Domestic Licensing of Production and Utilization Facilities" regulations to require all nuclear power plant licensees to use in-core monitoring devices at different elevations and radial positions throughout the reactor core. The NRC is not requesting public comment on this PRM at this time.

National Operator Licensing Examiners Conference

On July 7-8, 2015, staff participated in the National Operator Licensing Examiners Conference hosted by Region II. This year's conference served as a forum to discuss challenges and experiences related to implementation of proposed changes to NRC's Operator Licensing program. The proposed changes derived from a comprehensive lessons learned initiative following a 2014 decision from the Atomic Safety and Licensing Board to award a Senior Reactor Operator license to an applicant from the Vogtle Electric Generating Plant. The next step in the change process will be the formal routing, concurrence, and public comment period for NUREG 1021, "Operator Licensing Examination Standards for Power Reactors."

<u>Differing Professional Opinion Regarding the Definition of a Repetitive Degraded</u> <u>Cornerstone</u>

On June 11, 2015, the Director, NRR, issued a decision on a Differing Professional Opinion (DPO) submitted on December 7, 2014, concerning a change in the definition of a repetitive degraded cornerstone. The DPO raised concerns that the revision made to Inspection Manual Chapter (IMC) 0305 that changed the definition of a repetitive degraded cornerstone was an unnecessary relaxation in regulatory oversight and was contrary to Commission direction. On May 5, 2015, an Ad Hoc Panel (Panel) provided the results of its independent review of the DPO to the Director, NRR. The Panel concluded that the revision to IMC 0305 was a slight relaxation in regulatory oversight. The Panel did not believe that the change needed to be rescinded. The Panel also concluded that the change did not require prior notification or approval from the Commission before it was implemented. Finally, the Panel concluded that making multiple changes one at a time to the reactor oversight process (ROP) guiding documents could lead to unintended consequences. The Panel recommended assessing the potential unintended consequences of changing the definition of a repetitive degraded cornerstone, developing a technical bases document to capture the reasons for decisions that change the ROP, establishing basic thresholds for when a change would be viewed as "substantive," as well as for the method and content of communications to the Commission in that case, and developing guidelines for a process to evaluate aggregate/cumulative effects of changes to the ROP. The Director, NRR, agreed with the Panel on the conclusions and recommendations. Public Workshop on Standardized Plant Analysis Risk Model Program

On July 14-15, RES, in collaboration with Idaho National Laboratory staff, held a two-day public workshop on the agency's Standardized Plant Analysis Risk (SPAR) model program. Workshop discussions included: the objectives of the SPAR model program, data collection, and analysis; human reliability analysis; loss of offsite power modeling; and SPAR model maintenance and quality assurance. The workshop participants included representatives from utilities, industry contractors, international partners, and public interest groups. The SPAR models provide agency risk analysts with an independent risk assessment tool and support a variety of risk-informed agency programs including the reactor oversight process and the accident sequence precursor program.
