Computational Fluid Dynamics Linux Cluster Refresh

On August 6, 2015, as a result of a non-competitive solicitation, firm-fixed price contract NRC-HQ-60-15-C-0008 was awarded to Aspen Systems, Inc. in Wheat Ridge, Colorado. The objective of this contract is to deliver, install, and upgrade the Office of Nuclear Regulatory Research's existing Computational Fluid Dynamics Linux Cluster equipment. The period of performance is August 11, 2015, through October 16, 2015. The total price ceiling is \$156,904.

On August 7, 2015, as a result of a non-competitive solicitation, cost-reimbursement interagency agreement NRC-HQ-40-15-I-0003 was awarded to the Department of Energy, in Germantown, Maryland. The objective of this interagency agreement is to provide qualified personnel to serve as Hearing Examiners for personnel security administrative review hearings, as well as members of personnel security review panels. The period of performance is August 1, 2015, through July 31, 2020. The total cost ceiling is \$213,101.

Perspectives on Reactor Safety (R-800) Course

On August 10, 2015, as a result of a competitive solicitation, firm-fixed-price contract NRC-HQ-84-15-C-0010 was awarded to Trinitek Services, Inc. in Cedar Crest, New Mexico. The objective of this contract is to obtain expert technical instruction services to provide training on the safety issues surrounding the operation of nuclear power plants. The period of performance is September 30, 2015, through September 29, 2016. The total price ceiling is \$739,214.

Review of Risk-Informed Evaluation of the Boiling Water Reactor Owners Group Treatment of the Effects of Debris on Emergency Core Cooling Suction

On August 10, 2015, as a result of a non-competitive solicitation, cost-reimbursement task order NRC-HQ-20-15-T-0019 was issued under enterprise-wide agreement NRC-HQ-50-14-E-0001 to Southwest Research Institute, in San Antonio, Texas. The objective of this task order is to provide unique technical expertise in assisting the NRC in completing its review of the risk-informed evaluation being conducted by the Boiling Water Reactor Owners Group. The period of performance is August 10, 2015, through September 30, 2017. The total price ceiling is \$507,263.

Enhancing Guidance for Evacuation Time Estimate Studies

On August 10, 2015, as the result of a competitive solicitation, cost-reimbursable contract NRC-HQ-60-15-C-0007 was awarded to the Louisiana State University, in Baton Rouge, Louisiana. The objective of this contract is to conduct an applied research study of NRC guidance for developing Evacuation Time Estimate studies and produce a technical basis for revision of NUREG/CR-7002 "Criteria for Development of Evacuation Time Estimate Studies." The period of performance is August 10, 2015, through August 9, 2018. The total cost ceiling is \$940,914.

Environmental Impacts of Severe Reactor and Spent Fuel Pool Accidents: Petition for Rulemaking; Denial; Part 51 of Title 10 of the Code of Federal Regulations (PRM-51-14, et al.; NRC-2011-0189)

On August 12, 2015, the NRC published a denial of 15 petitions for rulemaking in the *Federal Register* (80 FR 48235). The petitions requested that the NRC rescind its regulations that "reach generic conclusions about the environmental impacts of severe reactor and/or spent fuel pool accidents and therefore prohibit considerations of those impacts in reactor licensing proceedings." The dockets for the petitions were closed on August 12, 2015.

<u>Public Meetings for Environmental Scoping for the Diablo Canyon License Renewal</u> Application

On August 5, 2015, the staff held two public meetings in San Luis Obispo, CA, to discuss the status of the Diablo Canyon Power Plant Units 1 and 2 license renewal application review and to receive environmental scoping comments from the public. Approximately 280 people attended both meetings. Public comments were provided in support of and in opposition to license renewal. Topics for the comments received at the meetings included issues such as seismic safety, spent fuel storage, climate change impacts from failing to renew the operating licenses, and impacts from the operation of the cooling system. The public comment period will close on August 31, 2015. The staff plans to issue the draft Supplemental Environmental Impact Statement in August 2016.
