Library of Congress' FEDLINK Program

On November 18, 2015, as a result of a non-competitive solicitation, cost-reimbursement interagency agreement NRC-HQ-10-16-I-0001 was awarded to the Library of Congress, in Washington, DC. The objective of this agreement is to provide NRC access to the Library of Congress' FEDLINK Technical and General Research Database, which provides the following services: assisted acquisition of commercial information services; publications in any format; library support services; related accounting services; and related education, information, and support services. The period of performance is October 1, 2015, through September 30, 2020. The total cost ceiling is \$661,396.

XEROX Copier Leasing for Region II

Meeting to Discuss the Provisions on Steel and Modular Composite Construction in the American Institute of Steel Construction (AISC) Specification N690-2012, Supplement 1, Dated 2015

On November 23, 2015, RES sponsored a public meeting to discuss the provisions on safety-related steel and steel plate modular composite structures (SC structures) in the American Institute of Steel Construction (AISC) Specification N690-2012, Supplement 1, dated 2015, Specification for Safety-Related Steel Structures for Nuclear Facilities. During this information gathering meeting, the staff and its contractors engaged AISC experts to get clarifications on the technical bases and justification of certain provisions in the standard to inform resolution of their possible acceptance with or without potential exceptions. Review of the N690 standard is part of the NRC guidance update. The N690-2012 standard is a major update of the N690-1994 and its Supplement 2 dated 2004, which are the last editions of the standard addressed in the NRC guidance. Supplement 1 to the N690-2012 is the first U.S. standard for safety related SC structures which is not yet addressed in detail in NRC guidance. This meeting was well attended by interested internal and external stakeholders. Meeting presentations and the meeting summary will be posted on the public meeting website.

Byron Station Units 1 and 2 License Renewal

On November 19, 2015, the staff issued the renewed operating licenses for Byron Station, Units 1 and 2, authorizing operation for an additional 20 years beyond the original license expiration dates. The new expiration dates are October 31, 2044, for Unit 1, and November 6, 2046, for Unit 2. The staff completed its reviews as documented in the Safety Evaluation Report dated July 2015, and the Supplemental Environmental Impact Statement, NUREG-1437, Supplement 54, published in July 2015. The issuance of the Byron, Units 1 and 2, renewed licenses brings the total number of renewals to 80 reactor units.
