## Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending December 11, 2015

#### **Renewed License for Davis-Besse**

On December 8, 2015, the staff issued the renewed operating license for Davis-Besse Nuclear Power Station Unit 1, authorizing operation for an additional 20 years beyond the original license expiration date. The new expiration date is April 22, 2037. The staff completed its reviews as documented in the Safety Evaluation Report, and Supplement 1, dated September 3, 2013, and August 10, 2015, respectively. The Supplemental Environmental Impact Statement, NUREG-1437, Supplement 52, was published on April 30, 2015. The issuance of the Davis-Besse renewed operating license brings the total number of power reactor license renewals to 81 units.

### <u>Public Meeting for the Environmental Review of the Proposed Northwest Medical Isotopes Radioisotope Production Facility</u>

On December 8, 2015, the staff held a public scoping meeting in Columbia, Missouri, to gather information necessary to prepare an environmental impact statement to evaluate the impacts for construction, operation, and decommissioning of the proposed Northwest Medical Isotopes, LLC (NWMI) radioisotope production facility. The scoping comment period ends on January 4, 2016. The scoping meeting commenced with an open house, followed by an NRC presentation and opportunity to hear public comments. Approximately 30 members of the public attended the meeting. Comments received were generally in support of the proposed radioisotope production facility.
