Dear Governor Fallin:

In 1976, the U.S. Nuclear Regulatory Commission (NRC) adopted a recommendation from several State organizations, including the National Governors Association, that each State appoint a single person to act as a liaison to the NRC to help improve Federal/State cooperation. The NRC looks to the Governor-appointed State Liaison Officer to be the primary communication channel between the State and the NRC. The State Liaison Officer serves as the key person in the State to keep the Governor and other State agencies informed about issues under the NRC's jurisdiction (specifically matters addressing nuclear regulation, nuclear security, nuclear emergency preparedness, and radiological public health and safety) and to provide the NRC with State information on particular nuclear safety, security, and environmental issues.

I am writing to request the continued participation of the State of Oklahoma in the NRC's State Liaison Officer program. The NRC has been working with the State Liaison Officer appointed by a former governor: Mr. Mike Broderick, Environmental Programs Manager for the Radiation Management Section in the Oklahoma Department of Environmental Quality. The NRC will continue to work with Mr. Broderick to keep you informed of our programs and activities, however, to ensure continued clear communication between the NRC and the State of Oklahoma, I would appreciate receiving your written affirmation of Mr. Broderick, or another individual as your selected appointee as State Liaison Officer for the State of Oklahoma.

I am providing you with a copy of the NRC brochure entitled, "State Liaison Officer Program," which provides background information on, and describes the role of, the State Liaison Officer. I am also enclosing a copy of the NRC "2015-2016 Information Digest," which provides information describing the NRC's mission and its regulatory programs.
