ANNETTE VIETTI-COOK: The first item is SECY-15-0013B Exelon Generation Company Dresden Nuclear Power Station. The Commission is being asked to act on a Memorandum and Order addressing the appeal of Local 15, International Brotherhood of Electrical Workers, AFL-CIO, of the Atomic Safety and Licensing Board's decision in licensing board panel 14-14 [corrected to be 14-4] denying Local 15's request for hearing on Confirmatory Order EA-13-068. The Commission (with Commissioner Baran dissenting) has voted to approve a Memorandum and that dismisses Local 15's appeal as moot and terminates the proceeding. Would you please affirm your votes?

ANNETTE VIETTI-COOK: Ok, so the second item is SECY-15-0171 Entergy Nuclear Operations, Inc. Indian Point Nuclear Generating station, Unit 2. The Commission is being asked to act on a Memorandum and Order responding to the State of New York's appeal of licensing board panel 15-26, in which the Atomic Safety and Licensing Board denied New York's intervention petition associated with a license amendment request to decrease the frequency of containment integrated leak rate tests at Indian Point, Unit 2.

The Commission has voted to approve a Memorandum and Order that affirms the Board's decision in licensing board panel 15-26. Would you please affirm your votes?
