Advisory Committee on Reactor Safeguards Meeting with Exelon Generation Company Regarding LaSalle County Station. Units 1 and 2. License Renewal Safety Evaluation Report

On April 19, 2016, the staff and Exelon Generation Company met with the Advisory Committee on Reactor Safeguards (ACRS) License Renewal Subcommittee to discuss the LaSalle County Station, Units 1 and 2, License Renewal Safety Evaluation Report (SER) with Open Items. The SER contains two open items related to the weld examination coverage under the Reactor Vessel Inside Diameter Attachment Welds and Boiling Water Reactor Stress Corrosion Cracking aging management programs. The staff expects to issue the final SER in June 2016.
