<u>Urine Specimen Collection Services</u>

On April 27, 2016, contract number NRC-HQ-40-16-C-0012 was awarded to Forensic Drug and Alcohol Testing, LLC, in Chantilly, Virginia. The purpose of this contract is to procure all services necessary to conduct urine specimen collections for drug testing and occasional breath/alcohol tests in order to comply with Mandatory Guidelines for Federal Drug-Free Workplace Programs and NRC requirements set forth in NRC's Drug-Free Workplace Plan and NRC's Contractor Drug Testing Plan. The period of performance is from June 1, 2016, through May 31, 2017, with four option years. The total potential value over the life of the contract is \$1,534,760.10.

Building Operations and Maintenance Services

On April 28, 2016, contract number NRC-HQ-40-16-C-0011 was awarded to CTSI-FM, LLC, in Halethorpe, Maryland. The purpose of this contract is to provide all personnel, equipment, supplies, facilities, transportation, tools, materials, supervision, and other items and non-personal services necessary to perform the operation and maintenance of the headquarters facilities. The period of performance is from April 27, 2016, through April 26, 2017, with four option years. The total potential value over the life of the contract is \$15,843,523.02.

Pre-licensing Meeting with Dominion Resources

On April 26, 2016, a pre-licensing public meeting was held between representatives of Dominion Resources and the staff at NRC Headquarters, Rockville, MD, to discuss a proposed license amendment request for North Anna Power Station, Units 1 and 2. The proposed license amendment would modify the fuel enrichment, new fuel storage racks, and the spent fuel pool.

Pre-licensing Meeting with Duke Energy Carolinas. LLC

On April 28, 2016, a pre-licensing public meeting was held between Duke Energy Carolinas, LLC, and the staff at NRC Headquarters, Rockville, MD, to discuss a proposed license amendment request (LAR) for the Catawba Nuclear Station, Units 1 and 2. The proposed license amendment would request to add a description to the Technical Specification Bases for crediting an emergency diesel generator on a unit in MODE 5 or 6 as the emergency power source for operability of the components of four shared systems aligned to the opposite unit in MODES 1, 2, 3, or 4. The licensee plans to submit the LAR by the end of May 2016.

<u>Catawba Nuclear Station Unit 1 - Approval of Measurement Uncertainty Recapture (MUR)</u> <u>Power Uprate</u>

On April 29, 2016, the staff approved a 1.7% MUR power uprate for the Catawba Nuclear Station, Unit 1, using Cameron CheckPlus Leading Edge Flow Meter ultrasonic flow measurement instrumentation. The MUR power uprate approved a thermal power increase from 3411 MWt to 3469 MWt, which corresponds to an increase from 1167 MWe to 1187 MWe. The amendment was issued for both Catawba Units because they have common Technical Specifications. However, the MUR power uprate is only applicable to Unit 1. Duke Energy Carolinas, LLC, plans to implement the MUR power uprate by the end of May 2016 for Unit 1. Duke Energy submitted the MUR power uprate request by letter dated June 23, 2014.
