Dear Mr. Peters:

On May 26, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at the Comanche Peak Nuclear Power Plant, Units 1 and 2. The NRC inspectors discussed the results of this inspection with Mr. T. McCool, Site Vice President, and other members of the licensee staff. The inspectors documented the results of this inspection in the enclosed inspection report.

The NRC inspectors documented one finding of very low security significance (Green) in this report. This finding involved a violation of NRC requirements. In addition, inspectors documented a licensee-identified violation which was determined to be of very low security significance. The NRC is treating these violations as a non-cited violations consistent with Section 2.3.2.a of the Enforcement Policy.

If you contest the violations or significance of the non-cited violations, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, DC 20555-0001, with copies to the Regional Administrator, Region IV; the Director, Office of Enforcement, U.S. Nuclear Regulatory Commission, Washington, DC 20555-0001; and the NRC resident inspectors at the Comanche Peak Nuclear Power Plant.
