**Personnel Security Adjudication Tracking System Enhancements and Modernization**

On August 10, 2016, contract number NRC-HQ-40-16-C-0016 was awarded to Chainbridge Solutions, Inc. in Centerville, Virginia. The objective of this contract is to obtain development, modernization and enhancement software configuration services from the contractor for the Personnel Security Adjudication Tracking System, in order to improve system efficiency, enhance user functionality, integrate with other NRC IT systems, and ensure compliance with Federal personnel security standards. The period of performance is from August 10, 2016, through August 9, 2017. The total value of the contract is \$910,755.

**Research and Technical Assistance Related to Severe Accidents in Nuclear Power Plants**

On August 12, 2016, Enterprise-Wide Contract number NRC-HQ-60-16-E-0001 was awarded to the University of Wisconsin System, in Madison, Wisconsin. The objective of this contract is to acquire support in a wide range of technical and scientific disciplines, in performing work-related activities aimed at enhancing safety in nuclear power plants. The period of performance is from August 12, 2016, through August 11, 2017, with four option years. The potential value of the life of the contract is \$2,212,854.

**National Nuclear Security Administration Research and Test Reactor Fuel Conversion Meeting**

On August 16, 2016, staff met with representatives of the National Nuclear Security Administration (NNSA) to discuss the coordination of efforts related to research reactor fuel conversions and molybdenum-99 (Mo-99) production. Specific topics related to fuel conversion included updates on mini-plate-1 fuel fabrication, the base fuel qualification report, fuel eutectics, and expected application submittal dates for the remaining conversions. With respect to Mo-99, discussions focused on the status of NNSA cooperative agreements and the uranium lease and takeback program.
