On August 25, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at the Limerick Generating Station, Units 1 and 2. The inspection covered one of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report documents the inspection results, which were discussed on August 25, 2016, with Mr. David Lewis, Plant Manager, and other members of your staff.

The inspection examined activities conducted under your licenses as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your licenses. The inspector reviewed selected procedures and records, observed activities, and interviewed personnel.

No findings were identified during this inspection.
