Pre-Licensing Meeting with Virginia Electric and Power Company (Dominion)

On September 7, 2016, the staff held a pre-licensing meeting with representatives of Dominion at NRC Headquarters, Rockville, MD, to discuss the licensee's plans to submit a relief request to use carbon fiber reinforced polymer as the pressure boundary in the Surry Power Station, Units 1 and 2, service water buried concrete encased piping.

Enhancing Participation in NRC Public Meetings: Proposed Revision to Policy Statement; Request for Comments (NRC-2016-0178)

On August 31, 2016, the NRC published a document in the *Federal Register* ([81 FR 60026](#)) proposing to revise its public meeting policy to further clarify and enhance participation in public meetings conducted by the NRC. The revised policy statement redefines the three categories of public meetings, identifies the level of public participation offered at each type of meeting, and clarifies notification expectations for meetings that include physical presence in the meeting room and meetings that rely solely on remote access technology such as a teleconferencing. Comments are requested by November 14, 2016.

Close Circuit Video System (CCVS) for the NRC White Flint North Campus

On August 31, 2016, contract number NRC-HQ-40-16-C-0017 was awarded to Concord Crossroads, in Manassas, Virginia. The objective of this contract is to provide the replacement and upgrade of the existing CCVS and video management applications in the White Flint North campus. The period of performance is from September 1, 2016 through March 31, 2017. The total value of the contract is \$806,965.

Revision of Fee Schedules; Fee Recovery for Fiscal Year 2016: Final Rule; Correcting Amendment; Part 171 of Title 10 of the Code of Federal Regulations (Regulation Identifier Number 3150-AJ66; NRC-2015-0223)

On September 6, 2016, the NRC published a document in the *Federal Register* ([81 FR 61100](#)) correcting the fiscal year (FY) 2016 final fee rule published on June 24, 2016 ([81 FR 41171](#)). The final rule became effective August 23, 2016, and amended the licensing, inspection, special project, and annual fees charged to NRC applicants and licensees. This document corrects the annual fee for materials licensees in the category "Nuclear laundries" from the FY 2016 rate of \$0 to the FY 2015 rate of \$40,100. This correction allows Agreement States to continue to collect fees in this fee category. The correction was effective on September 6, 2016.
