On September 30, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Comanche Peak Nuclear Power Plant, Units 1 and 2. On September 29, 2016, the NRC inspectors discussed the results of this inspection with Mr. Steven Sewell, Senior Director of Engineering and Regulatory Affairs, and other members of your staff. The inspectors documented the results of this inspection in the enclosed inspection report.

The NRC inspectors did not identify any findings or violations of more than minor significance.
