List of Approved Spent Fuel Storage Casks: Holtec International HI-STORM UMAX Canister Storage System; Certificate of Compliance No. 1040, Amendment No. 2: Direct Final Rule; Part 72 of Title 10 of the Code of Federal Regulations (Regulation Identifier Number 3150-AJ80; NRC-2016-0155)

On October 25, 2016, the NRC published a direct final rule in the Federal Register (<u>81 FR</u> <u>73335</u>) amending its spent fuel storage regulations by revising the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 2 to Certificate of Compliance No. 1040 for the Holtec International HI-STORM UMAX [Underground Maximum Capacity] Canister Storage System. The companion proposed rule was also published in the Federal Register on October 25, 2016 (<u>81 FR 73355</u>). Unless significant adverse comments are received, the direct final rule will become effective on January 9, 2017.

<u>Meeting of the Federal Committee for Meteorological Services and Supporting Research</u> (FCMSSR)

On October 20, 2016, NRC staff attended a meeting to approve recent updates to the Charter of the FCMSSR. The FCMSSR Charter was recently signed by the Director of Nuclear Regulatory Research for the NRC and provides a formal mechanism for interagency coordination on implementing national policy relating to developing plans and procedures for cooperative federal agency efforts. The agencies represented on the FCMSSR include the National Oceanic and Atmospheric Administration (as the chair) for the Department of Commerce, the Departments of Agriculture, Defense, Energy, Homeland Security, Interior, State, and Transportation; the Environmental Protection Agency; the National Aeronautics and Space Administration; the National Science Foundation; the National Transportation Safety Board; the Nuclear Regulatory Commission; the Office of Management and Budget; and the Office of Science and Technology Policy. The efforts involve the development, acquisition, continuous operability, and increased effectiveness of meteorological services for the Nation. Specific items discussed include plans for a national earth system prediction capability, plans for a revised process for the annual plan for meteorological services, and plans for a spectrum efficient national surveillance radar.
