FINAL RULEMAKING PLAN TEMPLATE

The purpose of this memorandum is to submit for Commission review and approval a final rulemaking plan template. In SECY-15-0129 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML15267A759), "Commission Involvement in Early Stages of Rulemaking," dated October 19, 2015, the U.S. Nuclear Regulatory Commission (NRC) staff requested Commission approval of its proposed plan to increase the Commission's involvement in the rulemaking process with the objective of ensuring early Commission engagement before expending significant NRC staff resources. In the staff requirements memorandum (SRM) for SECY-15-0129 (ADAMS Accession No. ML16034A441), dated February 3, 2016, the Commission approved most of the staff's recommendations including the need to submit a rulemaking plan (in the form of a template-based, brief notation vote paper) for Commission approval for all rulemakings except those that had already been explicitly delegated to the staff.

Enclosure 1 to this memorandum is the final rulemaking plan template for Commission approval. The rulemaking plan template incorporates the modifications noted in the SRM for SECY-15-0129 and is consistent with the Joint Explanatory Statement accompanying the Consolidated Appropriations Act, 2016 (Public Law 114-113). The template now includes the criteria that trigger a rulemaking review by the Committee to Review Generic Requirements.

To improve the template's usability, the staff has included for approval additional changes to the template aimed to improve both document authoring and the clarity of the rulemaking plans. Finally, the template complies with the format requirements for Commission correspondence in Management Directive 3.57, "Correspondence Management" (http://www.internal.nrc.gov/policy/directives/catalog/md3.57.pdf).
