Guidance for Implementation of 10 CFR 50.59, Changes, Tests, and Experiments: Draft Regulatory Guide; Request for Comment; Part 50 of Title 10 of the Code of Federal Regulations (10 CFR)(NRC-2016-0270)

On December 23, 2016, the NRC issued for public comment in the *Federal Register* (81 FR 94275) draft regulatory guide (DG), DG-1334, "Guidance for Implementation of 10 CFR 50.59, Changes, Tests, and Experiments." This draft regulatory guide provides licensees and applicants with a method that the staff of the NRC considers acceptable for use in complying with the Commission's regulations on the process by which licensees may make changes to their facilities and procedures, as described in the safety analysis report, without prior NRC approval, under certain conditions. The comment period on the DG closes on February 21, 2017.

<u>Unified Agenda of Federal Regulatory and Deregulatory Actions: Semiannual Regulatory Agenda; 10 CFR Chapter 1 (NRC-2015-0222)</u>

On December 23, 2016, the NRC published in the *Federal Register* (81 FR 94894) its Semiannual Regulatory Agenda (the Agenda) in accordance with Public Law 96-354, "The Regulatory Flexibility Act," and Executive Order 12866, "Regulatory Planning and Review." The Agenda is a compilation of all rules on which the NRC has recently completed action or has proposed or is considering action. This issuance of the NRC's Agenda contains 26 active and 23 long-term rulemaking activities: One is Economically Significant; 7 represent Other Significant agency priorities; 39 are Substantive, Nonsignificant rulemaking activities; and 2 are Administrative rulemaking activities. In addition, 2 rulemaking activities impact small entities. Comments are requested by January 23, 2017.

Rulemaking Activities Being Discontinued by the NRC: Rulemaking Activities;

Discontinuation; 10 CFR Parts 20 and 50 (Regulation Identifier Numbers (RIN) 3150-AJ38 and 3150-AJ29; NRC-2009-0279 and NRC-2014-0044)

On December 28, 2016, the NRC published a document in the *Federal Register* (81 FR 95410) discontinuing the rulemaking activities associated with potential changes to its radiation protection and reactor effluents regulations. The purpose of this action is to inform members of the public that these rulemaking activities are being discontinued and to provide a brief discussion of the NRC's decision to discontinue them. These rulemaking activities will no longer be reported in the NRC's portion of the Unified Agenda of Regulatory and Deregulatory Actions (the Unified Agenda). Effective December 28, 2016, the rulemaking activities discussed in this document are discontinued.
