Adjustment of Civil Penalties for Inflation for Fiscal Year 2017: Final Rule; Title 10 of the Code of Federal Regulations (10 CFR) Parts 2 and 13 (Regulation Identifier Number (RIN) 3150-AJ82; NRC-2016-0165)

On January 24, 2017, the NRC published a final rule in the *Federal Register* (82 FR 8133) to adjust the maximum civil monetary penalties (CMPs) it can assess under statutes enforced by the agency. These changes are mandated by the Federal Civil Penalties Inflation Adjustment Act of 1990, as amended by the Federal Civil Penalties Inflation Adjustment Act Improvements Act of 2015. The NRC is amending its regulations to adjust the maximum CMP for a violation of the Atomic Energy Act (AEA) of 1954, as amended AEA, or any regulation or order issued under the AEA from \$280,469 to \$285,057 per violation, per day. Additionally, the NRC is amending provisions concerning program fraud civil penalties by adjusting the maximum CMP under the Program Fraud Civil Remedies Act from \$10,781 to \$10,957 for each false claim or statement. This final rule was effective on January 24, 2017.

List of Approved Spent Fuel Storage Casks: AREVA Inc., Standardized NUHOMS® Cask System, Certificate of Compliance No. 1004, Amendment No. 14, and Revision 1 of the Initial Certificate, Amendment Nos. 1 through 11, and Amendment No. 13; Direct Final Rule; Part 72 of 10 CFR RIN 3150-AJ86; NRC-2016-0200)

On January 25, 2017, the NRC published a direct final rule in the *Federal Register* (82 FR 8353) amending its spent fuel storage regulations by revising the AREVA Inc., Standardized NUHOMS® Cask System listing within the "List of approved spent fuel storage casks" to add Amendment No. 14, and Revision 1 to the Initial Certificate, Amendment Nos. 1 through 11, and Amendment No. 13 to Certificate of Compliance No. 1004. The companion proposed rule was also published in the Federal Register on January 25, 2017 (82 FR 8366). Unless significant adverse comments are received, this direct final rule will become effective on April 25, 2017.

Probabilistic Flood Hazard Assessment (PFHA) Research Workshop

From January 23 through 25, 2017, RES staff, in cooperation with NRC's Office of New Reactors (NRO) External Hazards Center of Expertise staff and the Electric Power Research Institute (EPRI), conducted a public workshop on Probabilistic Flood Hazard Assessment (PFHA) research. The purpose of the workshop was to inform internal NRC stakeholders, partner Federal agencies, industry, and the general public about PFHA research being conducted by RES in response to a user need from NRO. RES is collaborating with EPRI on research in this area under a NRC-EPRI Memorandum of Understanding on Collaborative Nuclear Safety Research. The workshop included presentations on research needs and priorities by NRO and NRR staff, EPRI, and industry. Technical presentations by RES staff, NRC contractors and EPRI covered research on climate, precipitation, riverine and coastal flood hazard assessment, as well as reliability of flood protection and flood mitigation. The workshop included a panel discussion on PFHA research activities by partner agencies NOAA/National Weather Service, U.S. Army Corps of Engineers, Tennessee Valley Authority, U.S. Department of Energy and the French Institute for Radiation Protection and Nuclear Safety. About 80 workshop attendees participated both in person and remotely via GoToWebinar. The workshop presentations and discussions will be available as a NUREG/CP proceedings.
