Revision of Fee Schedules; Fee Recovery for Fiscal Year (FY) 2017: Proposed Rule; Parts 170 and 171 of Title 10 of the Code of Federal Regulations (10 CFR) (Regulation Identifier Number (RIN) 3150-AJ73; NRC-2016-0081)

On January 30, 2017, the NRC published a proposed rule in the *Federal Register* (82 FR 8696) proposing to amend the licensing, inspection, special project, and annual fees charged to its applicants and licensees. The proposed amendments are necessary to implement the Omnibus Budget Reconciliation Act of 1990, as amended, which requires the NRC to recover approximately 90 percent of its annual budget through fees. The NRC is issuing the FY 2017 proposed fee rule based on NUREG 1100, Volume 32, "Congressional Budget Justification: Fiscal Year 2017," as adjusted to reflect re-baselining reductions approved by the Commission per the staff requirements memorandum for SECY-16-0009, "Recommendations Resulting from the Integrated Prioritization and Re-baselining of Agency Activities," dated April 13, 2016, in the amount of \$952.1 million, a decrease of \$50.0 million from FY 2016. The public comment period on the proposed rule closes on March 1, 2017.

On January 31, 2017, the NRC published a document in the *Federal Register* (82 FR 8805) confirming the effective date of January 9, 2017, for the direct final rule that was published in the *Federal Register* on October 25, 2016 (81 FR 73335). The direct final rule amended the NRC's spent fuel storage regulations by revising the "List of approved spent fuel storage casks" to include Amendment No. 2 to Certificate of Compliance No. 1040 for the Holtec International HI-STORM UMAX Canister Storage System.

RES Seminar, "Concrete Materials Research to Support Structural Performance of Nuclear Concrete Structures Affected by Alkali-Silica Reaction (ASR)"

On January 31, 2017, RES conducted a Research Seminar on concrete materials research to support the evaluation of the structural performance of nuclear ASR affected concrete structures. This effort is being conducted for NRC at the National Institute of Standards and Technology (NIST). Dr. Steven Feldman, one of the researchers on the project, presented a review of concrete material composition, alkali-silica reaction (ASR) degradation in concrete, and specifics of the concrete materials studies on the RES project. The seminar helped NRC staff understand the importance of concrete materials performance and its impacts on the structural performance of nuclear concrete structures affected by ASR in licensing reviews for operating and license renewal periods. The seminar was well attended by NRC staff and management, including technical and legal staff from headquarters, and the regions via VTC.
